**Resolution**: SEC confirmed the Minutes of the 23<sup>rd</sup> Meeting of the State Executive Committee held on 11<sup>th</sup> Dec, 2015.

Agenda Item No. 2: Approval of revised Flood Memorandum, 2015.

**Resolution**: Assam Flood Memorandum for 2015 was submitted to the Ministry of Home Affairs, Govt. of India in October, 2015 showing requirement of Fund of Rs. 1467.50 Crore against infrastructure and other damages and Rs. 58.69 Crore against GR, Ex-Gratia etc.. Total Financial assistance sought for was Rs. 1526.19 Crore to meet the loss caused by the Floods of 2015 in the State.

As per observations made by the Inter Ministerial Central Team during their visit of Flood affected districts of Assam and suggestions made during their review meeting with the Chief Secretary, Assam revised reports were obtained from the Departments and the districts as per revised formats prescribed. Accordingly, on the basis of reports received from PWD (Roads), Water Resource, Irrigation, Agriculture Departments & the districts concerned and inclusion of damages related to Urban floods under Guwahati Municipal Corporation, the Flood Memorandum for 2015 has been revised showing requirement of fund of Rs. 1465.02 Crore against infrastructure and other damages and Rs. 58.77 Crore for GR, Ex-Gratia etc.. Total Financial Assistance sought for, therefore, is now Rs. 1523.79 Crore.

SEC approved the revised Flood Memorandum for 2015 as proposed for submission to the Ministry of Home Affairs, Govt. of India immediately.
