P R E F A C E

This is the third volume of Hand Book of Government Circulars issued by the Revenue Department. This volume contains important circulars of durable value issued by different Branches of the Revenue Department between middle of 1990 and December, 1993. In this volume we have also incorporated some important circulars issued by DLR and DLRAR.

Relief and Rehabilitation Department was created in 1983 to deal with the cases of relief and rehabilitation assistance in cases other than Natural Calamities. Important circulars issued by the Relief and Rehabilitation Department have been compiled for the first time and placed in this volume along with the Revenue Circulars, since work of these two Departments are handled by the same set of officials at the secretariat and as also at the District level.

Earlier, two volumes of Hand Book of Government Circulars on Revenue matters were issued, first volume containing circulars from early 1950 to early 1981; and the second volume, issued on 31st July, 1990, containing circulars issued between 1981 and July, 1990. It is hoped that all officials of Revenue and Relief and Rehabilitation Department both at the Secretariat as well as at the field level would find this Hand Book useful for transacting official work.
