No. LA&A/694155/26: Whereas, Smti Dipti Gogoi, ALRS (DR- 2017), the then Circle Officer, Doboka Revenue Circle, Dist.- Hojai was placed under suspension w.e.f. 02/12/2022 vide Notification No. RDM- 11/247/2022-LR-REV/ecf 246863/8 dated 02/12/2022, for her unauthorized absence from duty reported by DC, Hojai and was last extended for another period of 3 (three) months w.e.f. 11/03/2026;

Whereas, the Suspension Review Committee has observed that the departmental proceeding initiated against the officer by issue of show cause vide RDM- 11/247/2022-LR-REV/ecf 246863/26 dated 19/07/2023 is ongoing and charges have been established by the Inquiry Officer in the Enquiry report dated 04/05/2024;

Whereas, the Suspension Review Committee has also noted the view of Personnel Department wherein it is opined that Revenue & DM Department may decide the appropriate penalty to the Delinquent Official and recommended Revenue & DM Department to impose the penalty & dispose the Departmental Proceedings expeditiously;

Whereas, the Committee has further observed that the circumstances that led to suspension of the Delinquent Officer and subsequent extension thereof still prevails;

Whereas, the Suspension Review Committee has recommended for extension of suspension of Smti Dipti Gogoi, ALRS (DR-2017), for another period of 3 (three) months w.e.f. 11/06/2026.

Therefore, considering the seriousness of the matter, the Governor of Assam is pleased to extend the period of suspension in respect of Smti Dipti Gogoi, ALRS (DR- 2017) for another period of 3 (three) months w.e.f. 11/06/2026 or till further order.
