No. LA&A/727374/19: Whereas, Shri Tanbir Yusuf Ahmed, ALRS (DR-2019), the then Circle Officer, Dalgaoon Revenue Circle, Dist.- Darrang and Circle Officer (A), Samaguri Revenue Circle, Dist.- Nagaon was placed under suspension w.e.f. 04/04/2025 vide Notification ECF No. RLR.641488/9 dated 23/04/2025, subsequent to his arrest on 04/04/2025 in connection with Vigilance PS Case No. 08/2025 U/S 13(1)(b)/13(2) and 12 of the PC Act, 1988 which was last extended for another period of 3 (three) months w.e.f. 25/02/2026;

Whereas, the Suspension Review Committee has observed that departmental proceedings have already been initiated against the officer by issue of show cause vide eCF No. RLR.641488/616 dated 20/08/2025 and the officer has submitted his reply to the show cause;

Whereas, the Suspension Review Committee has observed that the SSP, Chief Minister's Special Vigilance Cell, Assam has furnished current status of his judicial custody vide letter dated 18/02/2026 informing that he is enlarged on bail vide Special Court Order dated 08/10/2025;

Whereas, the Suspension Review Committee has also observed that the charges are of grave nature which involve amassing disproportionate assets against known sources of income and speculation in stocks, shares etc. that led to suspension of the Delinquent Officer and the departmental proceeding is pending against the suspended officer;

Whereas, the Suspension Review Committee has recommended for extension of suspension of Shri Tanbir Yusuf Ahmed, ALRS (DR-2019), by another 3 (three) months w.e.f. 25/05/2026;

Therefore, considering the seriousness of the matter, the Governor of Assam is pleased to extend the period of suspension in respect of Shri Tanbir Yusuf Ahmed, ALRS (DR-2019) for another period of 3 (three) months w.e.f. 25/05/2026 or till further order.
