## ORDER BY THE GOVERNOR NOTIFICATION

No. RDM.15011/159/2022/4: The following draft of certain rules further to amend the Assam Right to Fair Compensation and Transparency in Land Acquisition, Rehabilitation and Resettlement rules, 2015, hereinafter referred to as the principal Rules, which the Governor of Assam proposes to make in exercise of the power conferred by section 109 of the Right to Fair Compensation and Transparency in Land Acquisition, Rehabilitation and Resettlement Act, 2013 is hereby published, as required under section 112 of the said Act, for the information of all persons likely to be affected thereby and the notice is hereby given that the said draft rules shall be taken into consideration after the expiry of a period of fifteen (15) days from the date of publication of this notification in the Official Gazette

Any objection or suggestions, which may be received from any individual with respect to the said draft rules before the expiry of the period specified above shall be considered by the Government of Assam.

Objection or suggestions, if any, may be sent to the Secretary to the Government of Assam, Revenue and Disaster Management Department, Janata Bhawan, Dispur, Guwahati-781006.

Short title, extent and commencement.

- (1) These rules may be called the Assam Right to Fair Compensation and Transparency in Land Acquisition, Rehabilitation and Resettlement (Amendment) Rules, 2022.
  - (2) They shall have like extent as the principal Rules.
  - (3) They shall come into force on the date of their publication in the Official Gazette.

Amendment of

2. In the principal Rules, in rule 38, -

rule 38.

(i) in sub-rule (1), in the last line, for the punctuation mark "." The punctuation mark ":" shall be substituted and thereafter the following proviso shall be inserted, namely: -

"Provided that the compensation payable for lands of the tea gardens, the multiplication factor shall be same as that is applicable to the lands located in urban areas." (ii) in sub-rule (2), after clause (iii), the following new clause (iv) shall be inserted, namely: -

"(iv) in case of tea garden labourers (both permanent and temporary) who may be working in the affected area for three years prior to the acquisition of the land, whose primary source of livelihood stand affected by acquisition of land shall be eligible for a payment of 10% of the compensation amount payable towards acquisition cost of tea garden concerned."
