1.	Disposal completion date	December 31, 2023	January 15, 2024 (till midnight)
2.	Review of rejected cases completion date	December 31, 2023	January 15, 2024 (till midnight)

In view of the above, the District Commissioners of the implementing districts will ensure disposal and review of all admissible applications within the aforementioned extended time-frame fixed for **Mission Basundhara 2.0**. No further extension shall be allowed. For completing disposal within the timeline above it should be ensured that meeting of SDLAC, if necessary, should be held till 10.01.2024 and no further.

Director of Land Records & Survey etc. will oversee the progress of disposals and review with timely guidance with a view to complete the task within extended time line efficiently.
