**The following are the Terms and Conditions of service for the appointee:**

1. During his/her service period, he/she may be deputed or his/her services may be placed on attachment or on secondment basis to any other department/ sob-ordinate office/ public sector undertaking/society /Mission under the State Govt. within and outside the state having the same pay scale and Grade Pay for a period decided and specified by the State Govt.  
While on such Deputation or on attachment or placed on Secondment basis he/she shall continue to be guided by the Assam Civil Services (Conduct) Rules, 1965 and Assam Services (Discipline & Appeal) Rules, 1964.
2. The services of any selected candidate found to have furnished false/falsified information regarding educational qualification/ caste/ gender/ EWS status etc. in his/ her application and detected subsequently, will be terminated and legal action will also be taken as per law.
3. If a Candidate or any of his/her family members is availing benefits under the Orunodoi Scheme at the time of the appointment, he she or the concerned family member shall voluntarily opt out of the Scheme, as per Orunodoi Guidelines forgetting appointment to the post.
4. The appointee shall also have to furnish a signed undertaking/affidavit at the time of joining as- *"I ,.....(Name).....appointed as ..... In case of any detection to the contrary in due course, I shall be summarily discharged from the Service."*
