

2. The services of any selected candidate found to have furnished false/falsified information regarding educational qualification/caste/gender/EWS statue etc. in his/her application and detected subsequently , will be terminated and legal action will also be taken as per law.
3. If a Candidate or any of his/her family members is availing benefits under the Orunudoj Scheme at the time of the appointment, he/she or the concerned family member shall voluntarily opt out of the Scheme, as per Orunodoj Guidelines for getting appointment to the post.


